# MCA Summary of Legislation February 2014

## Corbett Unveils 2014-15 Budget, Healthy PA – Another Tough Year Ahead

Gov. Tom Corbett delivered his fourth budget address on February 4 to a joint session of the General Assembly, outlining his \$29.4 billion spending plan that he said "continues to drive the values of strategic investment and prudent fiscal management to address the commonwealth's core funding needs." Corbett's proposed budget focuses on three key areas: education, jobs, and health and human services. He announced his "Ready to Learn", and "Ready to Succeed" programs. His plan includes numerous charter school reforms as well.

Gov. Corbett also outlined his "JOBS1st PA" agenda, focusing on the manufacturing, energy, life sciences and technology industries. The JOBS1st PA plan includes private partnerships, on-the-job training reimbursements for young people with disabilities, and other initiatives.

Corbett also announced he was going forward with his "Healthy PA" plan, to provide assistance to low-income working folks to purchase private health insurance, as an alternative to simply tapping into federal money to expand Medicaid to help the same population.

## **UCC Reform Proposals Circulating**

Pennsylvania's Uniform Construction Code (UCC) has been controversial since its enactment in 1999. First because it wasn't as uniform as the name might suggest (lots of grandfathering and variance opportunities) and more recently because of the codes themselves. Brush fires over certain International Building Code (IBC) provisions would flare up periodically and often embroil the PA Legislature in the disputes. In an effort to remove itself from the role of arbiter of these complex issues, the Legislature created an advisory council (RAC) made up of individuals knowledgeable about codes. The RAC was charged with reviewing the IBC triennial updates prior to adoption as part of the code for Pennsylvania.

Well that seemed like a good idea at the time. But right after the RAC approved the first triennial updates it was asked to review, the Legislature jumped back into the fray and reversed the RAC by passing a statute to undue a controversial provision (you may recall the dispute over residential sprinklers). But the new law didn't just undue that one provision, it changed the procedures and composition of the RAC in such a way that Pennsylvania is unlikely to adopt any of the updates. Presently, the RAC must have a super majority of its members vote to adopt any changes from the updates. That is why the Pennsylvania code is stuck on the 2009 IBC.

There are a number of bills in both the House and Senate that propose changes that would make the RAC more functional. Senate Bill 1023 has passed through the Senate Labor and Industry committee already but not before it was amended to the extent that it changes the current process very little. A number of groups are advocating further reaching changes like eliminating the requirement for a super majority of the RAC to accept any changes. How successful those efforts will be is uncertain at this time.

## LOCAL/STATE GOVERNMENT/REGULATIONS

HB 1877 RE: Demolition Safety Act (By Rep. Bill Keller, et al)

Provides for demolition standards for buildings and structures in cities of the first class (Philadelphia), for permits, for inspections, for powers and duties of the Department of Labor and Industry and for training and enforcement; imposes penalties; and establishes the Demolition Safety Training and Enforcement Account. A municipality may elect coverage under this act. Demolition permits are required for a contractor or an owner of a property who will perform demolition work on a building or structure and a subcontractor or individual who is not an employee of the demolition permit holder. The department, the city, and municipalities that have elected coverage may assess an additional fee on each permit issued under the authority of this act and the Pennsylvania Construction Code Act in the amount of 15 percent of the total cost of the permit, which shall be deposited in the Demolition Safety Training and Enforcement Account and used for grants for enhanced enforcement of this act and the Pennsylvania Construction Code Act, including training and staffing of code administrators, construction code officials and inspectors, and associated administrative costs. The department shall annually report to the House and Senate Labor and Industry Committees.

#### LIABILITY

HB 1808 RE: Adverse Possession (By Rep. Kurt Masser, et al)

Amends Title 42 (Judiciary) providing for the reduction of the standard period for bringing an action for the acquisition of title through adverse possession under certain circumstances from 21 years to ten years for a property that is less than one-half acre in size and that contains a single-family home. The bill provides for definitions of eligible homes and circumstances as well as limitations on applicability and guidelines for mesne profits.

#### **MECHANIC'S LIEN**

SB 908 RE: Declaration of Homestead (by Sen. Mike Waugh, et al)

Amends Title 42 (Judiciary) adding a new subsection providing that subject to certain requirements, a primary residence owned by a judgment debtor shall be exempt from sale to satisfy a judgment if the debtor files a declaration of homestead with the county

recorder in his county of residence. Further provides that to be exempt from sale, the primary residence may have an assessed value of not more than \$300,000. If it is assessed at more than \$300,000, it may be sold but the judgment debtor is entitled to receive the first \$300,000 of the sale proceeds. Also provides the filing of the declaration of homestead does not prevent a primary residence from being sold to satisfy a judgment from mortgage foreclosure, unpaid property taxes or a mechanic's lien.

#### MINIMUM WAGE

HB 2034 RE: Minimum Wage Raise (by Rep. Mark Cohen, et al)

Amends the Minimum Wage Act to raise the minimum wage of tipped employees from its current level of \$2.13 per hour to 70 percent of the minimum wage. A schedule of increases over time is provided in the bill.

#### PREVAILING WAGE

HB 2050 RE: Building Blocks PA (by Rep. Steve Santarsiero, et al)

Amends the Public School Code, in grounds and buildings, to establish the Building Blocks PA program whereby the Commonwealth reimburses school districts for school construction projects. Powers of the Department of Education are outlined as well as the application of the prevailing wage and process and procedure for reimbursement application. The legislation further establishes a Public School Facilities Financing Commission, which shall review and make recommendations related to public school facility financing. The department shall promulgate necessary regulations. Effective immediately.

#### LOCAL/PROPERTY TAX REFORM

HB 2045 RE: Tax Exemption and Mixed-Use Incentive Program (by Rep. Jerry Stern, et al)

Authorizes local taxing authorities to exempt from real property taxation the assessed valuation of improvements to deteriorated properties and the assessed valuation of new construction within the respective municipal corporations designated deteriorated areas of economically depressed communities in the amounts and in accordance with the provisions and limitations set forth in the bill. If an area is zoned for mixed-use housing and development, improvements shall incorporate mixed-use housing and development that benefit the efficiency and economy of the community. The bill provides for an exemption schedule; establishes standards and qualifications; provides procedure for obtaining exemption incentives; and outlines eligibility requirements.
